Pursuant to Section 607.1006, Florida Statutes, the undersigned officer, being duly authorized, empowered and directed to act, hereby files this First Amendment to the Articles of Incorporation of LITTLE BASIN, INC., a Florida profit corporation (the "Corporation") and hereby certifies the following:

- 1. The name of the Corporation is "Little Basin, Inc."
- 2. The original Articles of Incorporation of the Corporation were filed with the Florida Department of State on July 31, 1990, with an effective date of July 30, 1990, under document number L90154.
