

After calling your office at (850) 487-6059 and speaking with one of your employee's #2 on October 20, 2000, I have enclosed my check #6322 in the amount of \$150.00 along with the Application for Reinstatement for the Corporation, Innovation Design Speed, Inc. per her instructions.

I did not receive either the first or second notice for my Annual Report, and therefore was unable to make a timely filing. Correction for the zip code under the mailing address also needs to be corrected.
