## ARTICLES OF INCORPORATION OF TAMPA BAY AREA SUPPORT SERVICES, INC.

The undersigned, who is a citizen of the United States, for the purpose of forming a not for profit corporation under the Florida Not for Profit Corporation Act, adopts the following articles of incorporation:

#### ARTICLE I

NAME

The name of this corporation is Tampa Bay Area Support Services, Inc.

### ARTICLE II PRINCIPAL OFFICE

The street address and mailing address of this corporation are 3704 Monarch Drive, Tampa, Florida 33618.

### ARTICLE III PURPOSE OR PURPOSES

The purpose for which this corporation is organized is to provide case management and support services, and other related services, to the developmentally disabled, as well as others requiring similar services, in order to assist such persons in fulfilling their highest potential in life and in the overall improvement of their quality of life, including their health, living accommodations, and educational, social and financial condition.

This corporation is organized exclusively for charitable, educational and scientific purposes, including, for such purposes, the making of distributions that qualify as exempt to organizations under section 501 (c)(3) of the Internal Revenue Code, or the corresponding provisions of any future federal tax code.

No part of the earnings of this corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above in this Article. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

### ARTICLE IV DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

### ARTICLE V MANNER OF ELECTION OF DIRECTORS

The business of this corporation shall be managed by a Board of Directors. There shall be three (3) directors initially. The initial directors are appointed by these articles of incorporation. Succeeding directors shall be elected in the manner provided in the By-Laws. The number of directors may be increased, and after such increase, may be decreased, from time to time as provided in the By-Laws.
