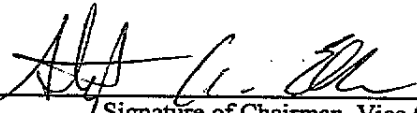

CHANGE TO THE ARTICLES OF INCORPORATION**

ARTICLE FOUR – DIRECTORS

The number of members of the Board of Directors shall be expanded to not less than twenty (20) nor more than thirty (30) at the first election thereof, and said membership shall thereafter remain at not less than twenty nor more than thirty (30) until these articles be amended; but in no event shall there ever be less than three (3) Directors. The Directors shall be elected at the annual meeting in January of each year and the Directors shall, at said meeting, also annually elect the officers of the not for profit corporation who shall manage the day-to-day affairs of the not for profit corporation.

CHANGES:

ARTICLE FOUR – DIRECTORS

The number of members of the Board of Directors shall be expanded to not less than twenty (20) nor more than thirty (30) at the first election thereof, and said membership shall thereafter remain at not less than twenty nor more than sixty (60) until these articles be amended; but in no event shall there ever be less than three (3) Directors. The Directors shall be elected at the annual meeting in June of each year and the Directors shall, at said meeting, also annually elect the officers of the not for profit corporation.

Remove: who shall manage the day-to-day affairs of the not for profit corporation.

ARTICLE EIGHT - AMENDMENTS TO ARTICLES

These Articles of Incorporation may be amended by the act of the Directors of the corporation. Such amendments may be proposed and adopted in the manner provided in the By-laws of the corporation upon a two-thirds (2/3) vote of the entire Board of Directors.

CHANGES:

ARTICLE EIGHT - AMENDMENTS TO ARTICLES

These Articles of Incorporation may be amended by the act of the Directors of the corporation. Such amendments may be proposed and adopted in the manner provided in the By-laws of the corporation.

Remove: upon a two-thirds (2/3) vote of the entire Board of Directors.
