



ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this Corporation is Seminole Springs Nursery, Inc. and the address is 27315 C.R. 44-A, Eustis, Florida 32736.

ARTICLE II - TERM OF EXISTENCE

The existence of this Corporation shall exist perpetually.

ARTICLE III - NATURE OF BUSINESS
