Jeffrey Pash, being duly sworn deposes and says:

1. I am Executive Vice President and League Counsel for the National Football League "NFL", a New York unincorporated association located and doing business at 280 Park Avenue, New York, New York 10017.
  
2. The NFL owns and used in interstate commerce, including in the State of Florida, the marks NATIONAL FOOTBALL LEAGUE, NFL, the NFL Shield Design, SUPER BOWL, SUPER BOWL XXXV, the Super Bowl XXXV Logo Design, AMERICAN FOOTBALL CONFERENCE, AFC, NATIONAL FOOTBALL CONFERENCE, NFC, "A" Design and "N" Design.
  
3. The NFL is exempt from the requirement that a business entity must obtain a Certificate of Authority to Transact Business from the Department of State in order to obtain a trademark registration in the State of Florida because the NFL qualifies under at least one of the exceptions to this rule as delineated in Florida Statute §607.1501(2).
  
4. The NFL, through National Football League Properties, Inc., its exclusive representative for the licensing and protection of its names, logos, symbols and other media, licenses independent contractors, i.e., sponsors and licensees, to produce and sell such products in the State of Florida. Thus, for trademark classes incorporating goods, the NFL is exempt from the need to obtain a Certificate of Authority pursuant to Florida Statute §607.1501(2)(e) which creates an exception for "[s]elling through independent contractors."
