ARTICLES OF INCORPORATION

OR

The undersigned, acting as the incorporator of a not-for profit corporation under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as amended, adopts the following Articles of Incorporation:

ARTICLE 1:NAME

The name of the Corporation shall be: "LA ESPERANZA EN ACCION", INC., Hereinafter referred to as the "Corporation".

ARTICLE 11:PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and the mailing address of the Corporation is 2831 N.W. 94 STREET, MIAMI, FLORIDA 33147.

ARTICLE III:DURATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

ARTICLE 1V:PURPOSES

The Corporation is organized and operated exclusively for charitable and educational purposes within the meaning Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended. Notwithstanding any other provision of these Article, the Corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986, (or the corresponding provision of any future United States Internal Revenue Law), or (ii) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE V:RESTRICTIONS ON ACTIVITIES

No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

ARTICLE V1:MEMBERSHIP

The Corporation shall be a membership organization in accordance with the bylaws.

ARTICLE V11:REGISTERED OFFICE AND AGENT

The Corporation's registered office shall be located at 2831 N.W. 94TH STREET, MIAMI, FLORIDA 33147. JORGE BAUTISTA, is the registered agent of the Corporation at that address.

Article V111: BOARDS OF DIRECTORS

The board of Directors shall consist of three (3) persons. The number of directos may be increased or decreased from time to time by an amendment to the by laws.

ARTICLE 1X: OFFICERS

ARTICLE X1: DISTRIBUTION OF ASSESTS UPON DISSOLUTION

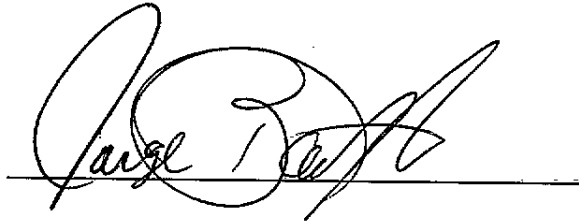

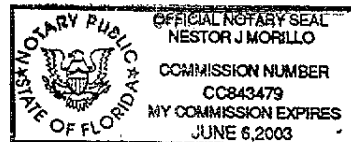
