**It as come to my attention our corporation has been
dissolved due to lack of filing the Business Report. I am
writing this letter to ask for reinstatement due to
hardship.**

**WSBZ Radio suffered a fire in the studio the evening of
August 18, 2000... destroying everything...
including all of our files. To make matters worse, the
fire also destroyed our home.. which was adjacent to the
radio station. We lost the business and a total of nine
animals that night. My first knowledge of this matter
came with the arrival of the Final Notice....that coming
in September. I did notice the zip code on the letter was
