

**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION

Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, filed July 12, 1976, and assigned Document Number 506918.

FIRST: The name of the corporation is: Price, Donoghue & Ridenour Management, P.A.

SECOND: The following amendment of the Articles of Incorporation was adopted by the corporation:

Change of Name:

To: Price, Donoghue & Ridenour, Inc.

THIRD: The following amendment of the Articles of Incorporation was adopted by the corporation:

The number of authorized shares of the Corporation is increased from Five Hundred (500) to Fifty Thousand (50,000) common shares with a par value of one-one hundredth of a dollar (\$0.01) per share.

FOURTH: The amendments were adopted by the Board of Directors on the 21 day of January, 2001 and said vote was sufficient for approval.
