**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF ORGANIZATION  
OF  
HBZ INVESTMENTS, L.L.C.**

Pursuant to the provisions of Section 608.411 of the Florida Statutes, the undersigned Limited Liability Company adopts the following Articles of Amendment to its Articles of Organization.

1. The date of filing of the Article of Organization was December 9, 1999.
2. Article I is deleted in its entirety and the following substituted in lieu thereof:

"The name of this Limited Liability Company shall be June Bug, L.L.C., a Florida limited liability company."

3. Article IV is deleted in its entirety and the following substituted in lieu thereof:

"The principal place of business of June Bug, L.L.C. shall be 6871 Belfort Oaks Place, Jacksonville, Florida 32216 and the mailing address shall be P.O. Box 551260, Jacksonville, Florida 32255 and such other place or places as the Members from time to time may determine.

The initial registered agent of June Bug, L.L.C. shall be Michael N. Schneider, whose address is 5150 Belfort Road, Building 100, Jacksonville, Florida 32256."

4. In all other respects, except as specifically changed and modified in these Articles of Amendment to the Articles of Organization, all of the provisions contained in the Articles of Organization of HBZ Investments, L.L.C. shall be and remain the same.
