ARTICLES OF ORGANIZATION FOR WINTER PARK VILLAGE APARTMENTS, LLC

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned (the "Members") acting as the organizers and the Members of Winter Park Village Apartments, LLC, under the Florida Limited Liability Company Act, Chapter 608, <u>Fla. Stat.</u>, adopt the following Articles of Organization:

ARTICLE I NAME

The name of the limited liability company is Winter Park Village Apartments, LIGO

ARTICLE II PURPOSE AND POWERS

- A. <u>Purposes</u>. The Company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to Chapter 608, <u>Fla. Stat.</u>, as the same may be amended from time to time.
- B. <u>Powers</u>. The Company shall have and may exercise all powers and rights which a limited liability company may exercise pursuant to Chapter 608, <u>Fla. Stat.</u>, as the same may be amended from time to time.

ARTICLE III INITIAL REGISTERED AGENT, REGISTERED OFFICE ADDRESS

The street address and mailing address of the initial corporate office and initial registered office of this Company is 2000 Village Lane, Winter Park, Florida 32792, and the name of the initial registered agent of this Company at that address is George R. Taylor.

ARTICLE IV DURATION

The Company's existence shall commence upon the acceptance of these Articles of Organization by the Secretary of State, and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

ARTICLE V MANAGEMENT

The management and control of the Company and its business and affairs is reserved to the Members of the Company as provided in the Operating Agreement of the Company.

ARTICLE VI ADMISSION OF ADDITIONAL MEMBERS

Except as otherwise provided in the Operating Agreement of the Company, the Company shall admit new Members only upon the unanimous written consent of all then existing Members of the Company.

ARTICLE VII MEMBERS RIGHTS TO CONTINUE BUSINESS

Unless otherwise provided in the Operating Agreement of the Company, the Company shall not be dissolved upon the death, retirement, resignation, expulsion, or bankruptcy of a Member.

ARTICLE VIII AMENDMENTS

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the unanimous written approval of all Members of the Company.
