



PROPOSED AMENDMENT TO THE **DECLARATION OF COVENANTS AND RESTRICTIONS OF** WOODSTREAM

ARTICLE I

TERMINATION OF PREVIOUS DECLARATION AND DEFINITIONS

Section 2. The following words when used in this Declaration or any Supplemental Declaration (unless the context shall prohibit) shall have the following meanings:

"Association" shall mean and refer to WOODSTREAM AT TUSCAWILLA WICKLOW HOMEOWNERS' ASSOCIATION, INC.

ARTICLE V

THE ASSOCIATION

Section 1. Woodstream at Tuscawilla Wicklow Homeowners' Association, Inc. (the "Association"), a Florida corporation not-for-profit, has been organized, among other things, to own, administer, and maintain the Common Areas. The Association shall act in accordance with the terms and provisions of this Declaration, the Articles of Incorporation of the Association and the By-Laws of the Association.

COVENANT FOR MAINTENANCE ASSESSMENTS

Section 6. The initial assessment shall be Three Hundred Dollars (\$300) per Lot (to be paid by the original Owner and again by each successor owner of a Lot at the time of
