ARTICLES OF ORGANIZATION OF

The undersigned desiring to form a Limited Liability Company under and pursuant to Section 608.407, Florida Statutes, of the State of Florida, do hereby certify as follows:

FIRST: The name of said limited liability company shall be SUBARASHII-DELI GOURMET, LLC, and the mailing address and the street address of the principal office of the limited liability company shall be 8506 NW 66 Street, Miami, Florida 33166.

SECOND: SUBARASHII-DELI GOURMET, LLC, shall have a perpetual duration from the date of filing of these Articles of Organization.

THIRD: The purposes for which SUBARASHII-DELI GOURMET, LLC is formed are:

- (A) to engage in any restaurant or deli gourmet ventures, establishing of a franchise of business opportunities and acquisitions;
