**ARTICLES OF AMENDMENT**

to

**ARTICLES OF INCORPORATION**

of

**CHRIST CHURCH OF PEACE, INCORPORATED**

*Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendments to its articles of incorporation.*

**FIRST:** Amendments adopted:

Article III is AMENDED as follows:

**ARTICLE III      PURPOSE**

The purpose for which the corporation is organized is:

Religious Organization.

Our Mission Statement: Christ Church of Peace is a worshipping and ministering community of believers on a spiritual journey of discovering and growth with a Christian foundation, embracing aspects of other faiths; and welcoming people of all races, nationalities, genders, sexual orientations and disabilities.

Said corporation is organized exclusively for religious and charitable purposes, including, for such purposes, the making of distributions to organization that qualify as exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VIII is ADDED as follows:

**ARTICLE VIII      EARNINGS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) of any political campaign on behalf of or in opposition to any candidate for

public office. Notwithstanding any other provisions of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article IX is ADDED as follows:

ARTICLE IX      DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**SECOND:** The date of adoption of the amendments was: 4/8/2001

**THIRD:** The amendments were adopted by the members and the number of votes cast for the amendment was sufficient for approval.
