The Partnership shall indemnify General Partner of the Partnership who was wholly successful, on the merits or otherwise, in the defense of any proceeding to which the General Partner was a party because the General Partner is or was a General Partner of the Partnership against reasonable attorney fees and expenses incurred by the General Partner in connection with the proceeding. The Partnership may indemnify an individual made a party to a proceeding because the individual is or was a General Partner of the Partnership against liability if authorized in the specific case after determination, in the manner required by the Partner(s), that indemnification of the General Partner, as the case may be, is permissible in the circumstances because the General Partner has met the standard of conduct set forth by the Partner(s), Florida Law, Rules, and Regulations. The indemnification and advancement of attorney fees and expenses for General Partner of the Partnership shall apply when such persons are serving at the Partnership's request while a General Partner of the Partnership, as the case may be, as a manager, officer, partner, trustee, employee or agent of another foreign or domestic Company, partnership, joint venture, trust, employee benefit plan or other enterprise, whether or not for profit, as well as in their official capacity with the Partnership. The Partnership also may pay for or reimburse the reasonable attorney fees and expenses incurred by a General Partner of the Partnership who is a party to a proceeding in advance of final disposition of the proceeding. All references in these Certificate of Limited Partnership are deemed to include any amendment or successor thereto. Nothing contained in these Certificate of Limited Partnership shall limit or preclude the exercise of any right relating to indemnification or advance of attorney fees and expenses to any person who is or was a General Partner of the Partnership or the ability of the Partnership otherwise to indemnify or advance expenses to any such person by contract or in any other manner. 


