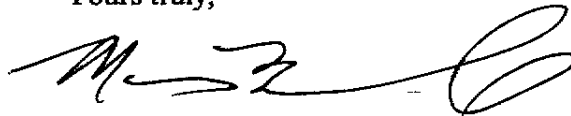

ARTICLES OF INCORPORATION
OF
NORTH FLORIDA JOINT TRAINING ASSOCIATION, INC.

ARTICLE I - NAME

The name of this nonprofit corporation is North Florida Joint Training Association, Inc. The principal place of business shall be at 5437 Cassidy Road, Jacksonville, Florida, 32254.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This nonprofit corporation is organized exclusively for educational purposes, including the making of distributions to organizations under Section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code) and the operation of a charter technical career center. This nonprofit corporation is formed and shall be operated exclusively for assistance, training, and educating individuals in apprenticeship and training programs, charter technical career centers, and other nonprofit purposes.

ARTICLE IV - ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed shall be provided for in the By-Laws of the Corporation.

ARTICLE V - LIMITATION OF CORPORATE POWERS

The corporate powers of this nonprofit corporation are as provided in Section 61.0302, Florida Statutes. No part of any net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the

corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in the furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any further Federal tax code) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any further Federal tax code).

ARTICLE VI – INITIAL REGISTERED AGENT AND OFFICE

The street address of the initial registered office of this nonprofit corporation shall be 2801 Ponce de Leon Boulevard, Suite 750, Coral Gables, Florida, 33134, and the name of the initial registered agent of this corporation at such office shall be Robert A. Sugarman, who upon accepting this designation agrees to comply with the provisions of §48.091, Florida Statutes, as amended from time to time, with respect to keeping an office open for service of process.

ARTICLE VIII – INDEMNIFICATION

The nonprofit corporation shall indemnify any Officer or Director or Incorporator to the full extent permitted by law.

ARTICLE IX – AMENDMENT

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, by a majority vote of the Board of Directors, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE X – DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any further Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.

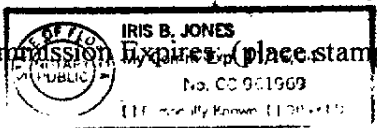
