ARTICLES OF INCORPORATION

FOR

BICHON FRISE RESCUE OF FLORIDA, INC.

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: Bichon Frise Rescue of Florida, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be 1304 SW 160th Avenue, Suite #250, Sunrise, Florida 33326. The principal mailing address of this corporation shall be P.O. Box 268195, Weston, Florida 33326.

ARTICLE III PURPOSE

Bichon Frise Rescue of Florida, Inc. is organized exclusively for charitable, scientific and educational purposes, more specifically to rescue and rehome abandoned or abused bichon frise dogs.

ARTICLE IV MANNER OF ELECTION

Election of new directors or election of current directors to a second term will occur as the first item of business at the annual meeting of the corporation. Directors will be elected to two-year terms by a majority vote of the current directors. The Board shall have up to four and not fewer than three members. The board receives no compensation other than reasonable expenses.
