In addition to the former, no substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in or intervene in ( including the publishing or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.
