NAME

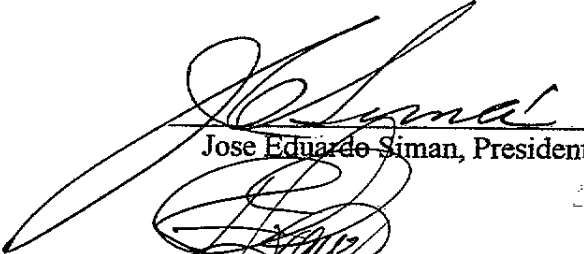
1. The name of this corporation shall be:

SALVADORAN AMERICAN HUMANITARIAN FOUNDATION, INC.

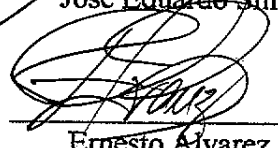
For the convenience, the corporation shall be referred to herein as the "Corporation".
