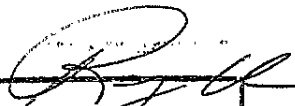

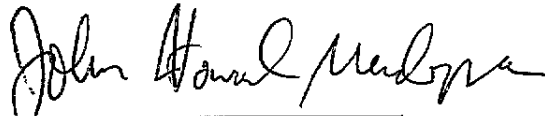
ARTICLE VII - Operation

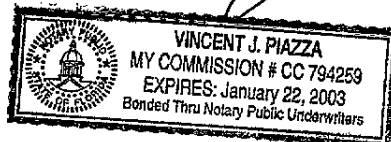
