The aggregate number of shares which the corporation shall have authority to issue is **THREE hundred (300) of no par value.**

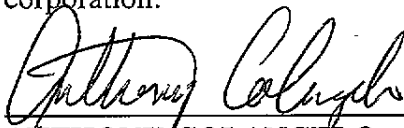
ARTICLE FIVE

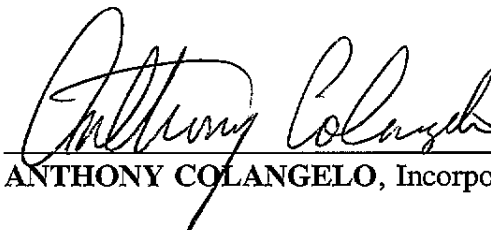
