

The undersigned, acting as incorporator of a Florida corporation under the Florida not for profit Corporation Act, Chapter 617 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME

The name of the Corporation is Access Foundation Corporation.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the Corporation's principal office is 1749 NE 26<sup>th</sup> Street, Suite F, Fort Lauderdale, Florida 33305 and the mailing address of the Corporation is the same.

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of raising and distributing charitable funds for philanthropic purposes as well as any other lawful purpose not for pecuniary profit.

ARTICLE IV – CERTIFICATES OF MEMBERSHIP

The Corporation is authorized to issue 1000 units of Certificates of Membership.

ARTICLE V- INITIAL REGISTERED AGENT AND OFFICE

The power to amend these Articles of Incorporation in accordance with law is reserved to the members. Any right conferred upon any member by these Articles of Incorporation is subject to this reservation.


