ARTICLES OF INCORPORATION OF RCA LIMITED, INC.

on ASECUAL AND SEE OF STATE OF

I, the undersigned, make subscribe, acknowledge and file with the Secretary of St of the State of Florida these Articles Of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I - NAME
