NAME

INDEMNIFICATION

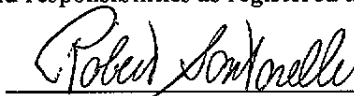
The corporation shall indemnify any officer or director or incorporator or former officer, director or incorporator, to the full extent permitted by law.
