We, the undersigned, for the purpose of forming a not for profit corporation in Accordance with the laws of the State of Florida, acknowledge and file these Articles of Incorporation in the Office of the Secretary of State of the State of Florida.

Articles I – Corporate Name

The name of the corporation is:

MIAMI SPRINGS HURRICANE CLUB, CORP.

Articles II – Purpose

This corporation is organized for the purpose of a youth little baseball League organization not organized for profit but operated exclusively for the promotion of a youth baseball team. The membership is limited to the parents and the children Of the Miami Springs Hurricane Club Corp. The net earnings of which are devoted exclusively for the development of a youth baseball team.

Article III - Existence

The club shall have perpetual existence, unless the members terminate pursuant to the provisions of its Declaration in which event the Club shall be dissolved in accordance with Florida law.

Article IV Principal Office

The principal office of the Club shall be located at 1325 West 5th Court, Hialeah, FL 33010, but the Club may maintain offices and transact business in such other places within or without the State of Florida as may from time to time be designated by the Board of Directors.
