FIRST: The name of said limited liability company shall be, RDD, LLC, and the mailing address and the street address of the principal office of the limited liability company shall be 789 Crandom Blvd., Ocean Club, Tower I, Suite 1104, Key Biscayne, Florida 33149.

SECOND: RDD, LLC, shall have a perpetual duration from the date of filing of these Articles of Organization.

THIRD: The purposes for which, RDD, LLC is formed are:

- (A) to engage in the export, import and distribution of a variety of products, and
- (B) to engage in such other lawful acts or activities for which limited liability companies may be formed under Chapter 608 of the Statutes of the State of Florida.






