ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF AMERICAN METAL SUPPLY, INC.

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

- 1. The name of the corporation prior to the filing of these Articles of Amendment is *American Metal Supply, Inc.* (the "Corporation").
