ARTICLES OF INCORPORATION

TO SELECTION OF THE PARTY OF TH The undersigned, acting as an Incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of the corporation shall be Incepture, Inc., a Florida for-profit corporation.

ARTICLE II

PRINCIPAL PLACE OF BUSINESS
