The undersigned incorporator of these Articles of Incorporation, being a natural person competent to contract, hereby presents these Articles of Incorporation to the Secretary of State for the State of Florida for the formation of a corporation under the laws of the State of Florida.

**ARTICLE I**

The name of this corporation is UMABK AGRICULTURE, INC.

**ARTICLE II**

The general nature of the business to be transacted by this corporation shall be:

A. To engage in the business of the purchase and sale of agricultural machinery and equipment and such other business as permitted under the laws of the State of Florida;

B. To invest the funds of this corporation in real estate; mortgages; stocks; bonds; or any other type of investment, and to own real and personal property necessary for the operation of the business; and

C. To transact any lawful business for which corporations may be formed under the laws of the State of Florida.

**ARTICLE III**

A. This corporation is to have perpetual existence.

B. The corporate existence of this corporation shall commence five (5) days prior to the date of filing hereof.

**ARTICLE IV**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is five thousand (5000) shares of common stock having no par value.

The corporation elects to have preemptive rights with respect to all issuance of shares including, but not limited to: (a) shares issued as compensation to directors, officers, agents or employees of the corporation or its subsidiaries or affiliates; (b) shares issued to satisfy conversion or option rights created to provide compensation to directors, officers, agents, or employees of the corporation or its subsidiaries or affiliates; and (c) shares issued within six months from the effective date of incorporation.
