**ARTICLE IV**

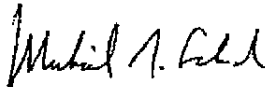

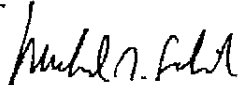

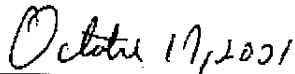
