Pursuant to the provisions of §607.1105 of the Florida Not for Profit Law (the "Florida Statutes"), the undersigned corporations adopted the following Articles of Merger for the purpose of merging United Hearing and Deaf Services, Inc., a Florida Corporation Not For Profit, with and into League for the Hard of Hearing, a New York Corporation Not For Profit.

1. The names of the corporations which are parties to this merger are United Hearing and Deaf Services, Inc. ("United Hearing"), and League for the Hard of Hearing (the "League"). The League shall be the surviving corporation. The Plan of Merger is attached hereto as Exhibit A.

2. On March 21, 2001, the Plan of Merger was approved by the directors of the League, and on July 26, 2001, the Plan of Merger was approved by the directors and members of United Hearing, each approval effected in the manner prescribed by the Florida Statutes.

3. United Hearing has 106 members entitled to vote, and 12 directors. The League has no members entitled to vote, and 35 directors.

4. (a) As to United Hearing, the total numbers of members and/or directors who voted for and/or against the Plan of Merger, respectively, are as follows:

ARTICLE I

NAMES OF CONSTITUENT CORPORATIONS AND OF SURVIVING  
CORPORATION

The names of the constituent corporations are United Hearing and Deaf Services, Inc. ("United Hearing") and League for the Hard of Hearing (the "League"). The League was formed under the name Nitchie Service League, Inc., and subsequently changed its name to The New York League for the Hard of Hearing, then to New York League for the Hard of Hearing, and then to League for the Hard of Hearing. The name of the surviving corporation is League for the Hard of Hearing.

ARTICLE II

MEMBERSHIP AND HOLDERS OF CERTIFICATES EVIDENCING CAPITAL  
CONTRIBUTIONS AND SUBVENTIONS

As to the League, the members and holders of any certificates evidencing capital contributions or subventions, including their number, classification, and voting rights, are described on Exhibit A hereto. As to United Hearing, the members and holders of any certificates evidencing capital contributions or subventions, including their number, classification, and voting rights, are described on Exhibit B hereto.

ARTICLE III

TERMS AND CONDITIONS OF PROPOSED MERGER

The manner and basis of converting membership in each constituent corporation into membership in the surviving corporation shall be as follows. Upon the effective date of the merger, each member of United Hearing, who had been classified as an "Individual" or "Family" member, will become a member of the League under the classification of "Individual/Family," as the League makes no distinction between these two classes of members.

#### ARTICLE IV

#### AMENDMENTS OR CHANGES IN CERTIFICATE OF INCORPORATION OF SURVIVING CORPORATION

There will be no amendments or changes in the Certificate of Incorporation of the League following the effective date of the merger as a result of the merger.

#### ARTICLE V

#### MISCELLANEOUS PROVISIONS

1. Effective Date of Merger. The proposed merger shall become effective upon the filing of the certificate of merger by the Department of State, and the certificate of merger shall not contain any provision to the contrary.

2. Abandonment of Plan. Notwithstanding approval of this plan by the members of either of the constituent corporations, if at any time prior to the filing of the certificate of merger by the Department of State it becomes the opinion of the board of directors of either of the constituent corporations that events or circumstances have occurred which render it inadvisable to consummate the merger this plan of merger shall be deemed abandoned. The filing of the certificate of merger shall conclusively establish that no action to terminate this plan has been taken by the board of directors of either of the constituent corporations.

3. Counterparts. For the convenience of the parties and to facilitate approval of this plan, any number of counterparts of this plan may be executed and each such executed counterpart shall be deemed to be an original instrument.
