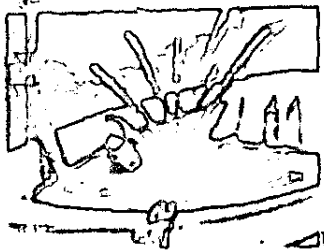

I spoke with you today regarding application for reinstatement. You recommended that I explain in writing why application was not sent in prior to now.

I started working in our office November 18, 2000. At this time, various licenses reinstatements, etc. were all new to me. I am still learning when and what is due. I found approximately of this year (2001) that our Division of Corporation paperwork was well overdue. I immediately called your office and I was told to send in application with a \$600.00 fee (overdue fee of application), which I completely understand the fee. At that time, I was told a way to remember that this was due that if I had not received a new bill by "Valentine's Day" to call and request another application.

Keeping all of this in mind, after FedExing reinstatement on January 17 with the \$600.00 fee I assumed I was covered for the year. However, I received the new application in April of this year.
