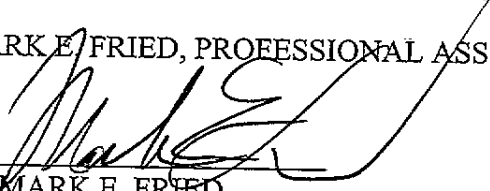

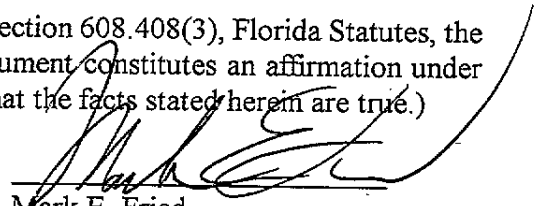
ARTICLE V – CONTINUATION AFTER VOLUNTARY TERMINATION
