The Articles of Incorporation are hereby amended by the following resolution adopted by both the Board of Directors and the Shareholders:

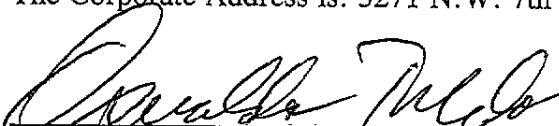
IT IS AS FOLLOWS:

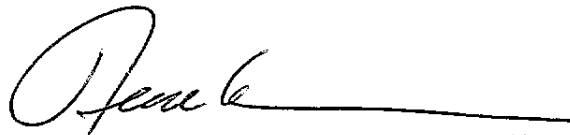
