### ARTICLE I

The name of the corporation shall be NAUTIC CONSULTING, INC. and the corporate principal address shall be 5366 Congo Ct., Cape Coral Fl. 33904

## ARTICLE II NATURE OF BUSINESS

The purpose of this corporation is to transact all lawful business.

Any director of the corporation may vote upon any transaction with the corporation without regard to the fact that he is also a director of such subsidiary or corporation.
