Articles of Amendment to the Articles of Incorporation of Richard J. Finder, M.D., P.A.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned professional corporation adopts the following Articles of Amendment to the Articles of Incorporation of Richard J. Finder, M.D., P.A.:

- 1. Article I of the Articles of Incorporation are hereby amended to provide that the name of this corporation will now be Finder & Masel, M.D., P.A.
- 2. Subparagraph (a) of Article III of the Articles of Incorporation of this corporation is hereby amended to read:

This total number of shares that the corporation is authorized to issue is 200, all of which are without par value and are of the same class and are Common shares. Each of said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders. All or any part of said Common shares shall be paid for in cash. All Common shares when issued shall be paid for and shall be nonassessable.

- 3. This amendment shall be effective upon the filing of these Articles of Amendment with the Florida Department of State.
