ARTICLES OF INCORPORATION

OF

ARTICLE I

The name of this corporation is R. C. EGGLETON CONSULTING, INC. Its principal place of business is 6251 Chariot Street, Port Charlotte, Florida 33981, and its mailing address is 6251 Chariot Street, Port Charlotte, Florida 33981.

ARTICLE II

This corporation shall have perpetual existence or shall exist until dissolved by operation of law.






