

I, the undersigned, hereby make, subscribe, acknowledge, and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a professional service corporation for profit (hereinafter the "corporation") in accordance with the laws of the State of Florida.



#### ARTICLE I

#### **Existence of Corporation**

This corporation shall begin existence on January 23, 2002, and shall have perpetual existence.

#### **Purposes**

This corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.

#### **ARTICLE IV**

#### **Powers**
