**Articles of Incorporation**

1. BE IT RESOLVED that Article VIII of the Articles of Incorporation be amended as follows:

**ARTICLE VIII, DIRECTORS**

Section 8.1 Number and Qualifications.

...The number of members of the succeeding Board of Directors shall be from three (3) ~~to five (5)~~ to seven (7).
