# ARTICLES OF ORGANIZATION

FOR

CURRY HOLDINGS, L.L.C.

A FLORIDA LIMITED LIABILITY COMPANY

## ARTICLE I - Name

The name of the Limited Liability Company is:

## ARTICLE II - Address
