The right, if given, of the members to transfer their interests (voluntarily or involuntarily) or of any person to succeed to their interest shall be as provided in the Operating Agreement for the Company and is: (1) expressly subordinate to any Domino's Pizza, LLC option to purchase all of the assets of any store (which constitutes an asset of the Company) upon the termination or expiration of the Domino's franchise under which the particular store is operated; (2) only capable of being made to an approved franchisee of Domino's Pizza, LLC as defined in its Standard Franchise Agreement; and (3) subject to Domino's Pizza, LLC's right of first refusal to acquire certain assets (store assets) of the L.C. in accord with its franchise rights.




