The name of the limited liability company is KARMA ENTERPRISES, LLC.

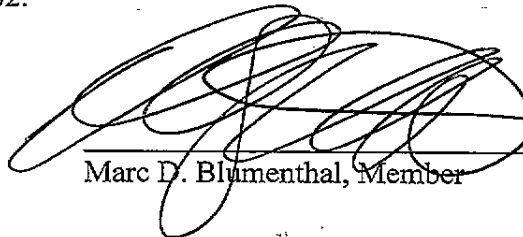
**ARTICLE II - Address:**

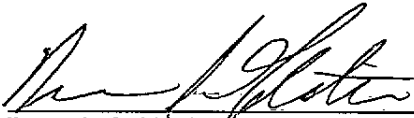
