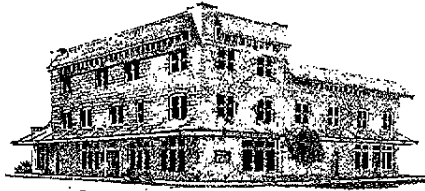

AMENDMENT TO THE ARTICLES OF INCORPORATION

The undersigned President and Secretary of GRADIE THORNTON MOTORS, INC., a corporation organized under the laws of the State of Florida, hereby certify:

1. That the name of the corporation is GRADIE THORNTON MOTORS, INC.
2. The Articles of Incorporation of said corporation are hereby amended by deleting all words and figures contained in Article IV - Capital Stock and inserting the following in place and stead thereof:

"ARTICLE IV - CAPITAL STOCK

The total number of shares of capital stock which may be issued by this corporation shall be two hundred (200) shares, which shall be common stock having no par value, all of which shall be fully paid and non-assessable."

3. In all other respects the Articles of Incorporation are ratified, reaffirmed and remain unchanged.
4. The above Amendment to the Articles of Incorporation of GRADIE THORNTON MOTORS, INC. were adopted by Unanimous Written Consent of the Board of Directors and Shareholders of GRADIE THORNTON MOTORS, INC. effective the 11th day of January, 2002.
