## ARTICLES OF ORGANIZATION OF COLONY WEST, LLC

- 1. Name. The name of this limited liability company is COLONY WEST, LLCO (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
