ARTICLES OF INCORPORATION  
OF

LOGOS - SCHOOL OF THE ARTS, INC.

In compliance with the requirements of F.S. Chapter 617, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a not-for-profit business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is LOGOS - SCHOOL OF THE ARTS, INC.

ARTICLE II

The existence of the Corporation shall begin on the date these articles of incorporation are filed with the Secretary of State.

ARTICLE III

The street address of the principal office of the Corporation is 12472 Lake Underhill, #284, Orlando, FL 32828.

ARTICLE IV

The purposes for which this corporation is formed are:

- A. The specific and primary purpose is to conduct a school of general education on a Preschool to High School level.
- B. The general Purposes and powers are to promote, foster, organize, and supervise the type of school specified in subparagraph (A) above.
- C. This Corporation shall have and exercise all rights conferred on for a profit corporation under the laws of Florida, including the power to contract, rent, buy or sell personal or real property, provided, however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.
- D. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation and the corporation shall not intervene in any political campaign on behalf of any candidate for public office.

ARTICLE V

The initial street address of the Corporation's registered office is 12472 Lake Underhill, #284, Orlando, FL 32828. The initial registered agent for the Corporation at that address is JANEL YOUNG.



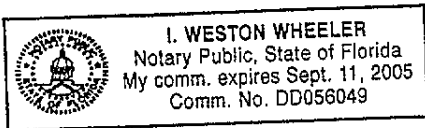

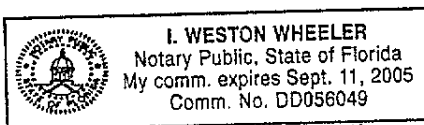
