These Articles constitute the Articles of The 15,000 Coalition, Inc., a corporation not-for-profit organized under the laws of the State of Florida.

Article I.

Name

The name of the Corporation is The 15,000 Coalition, Inc.

Article II.

Principal Office


**CERTIFICATE OF DESIGNATION AND
