ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF BLOUNT SIKES & ASSOCIATES, INC.

THE UNDERSIGNED, Lowry E. Rockett, President of BLOUNT SIKES & ASSOCIATES, INC., a Florida corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation:

ARTICLE FIRST: The name of the Corporation is BLOUNT SIKES & ASSOCIATES, INC.
