**INSIDE PROPERTY MANAGEMENT, L.L.C.**

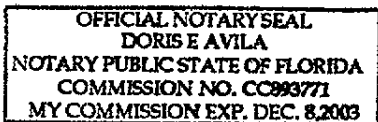


