ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF HEBREW HOMES HEALTH NETWORK, INC.

Pursuant to the provisions of Section 617.1001 of the Florida Not For Profit Corporation Act (the "Act"). Vasocor, Inc. (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

- I. The name of the Corporation is Hebrew Homes Health Network, Inc.
- II. The following amendments of the Articles of Incorporation were adopted by the members of the Corporation on May 28, 2002, in the manner prescribed by Section 617.1002 of the Act:
- a. <u>ARTICLE IV Purposes</u> is amended by adding at its end a new paragraph as follows:

other provision hereof, Notwithstanding any Corporation shall be operated exclusively for the benefit of, to perform the functions of or to carry out the purposes of the Hebrew Home of North Dade, Inc., Hebrew Home of South Beach, Inc., Arch Plaza Inc., Ponce Plaza, Inc., Jackson Plaza, Inc., Plaza North, Inc., Hebrew Homes Housing, Inc., Hebrew Homes Captive Services, Inc., Hebrew Homes Management Services, Inc., Hebrew and HHHN Homes Health Network Foundation, Inc., Staffing, Inc., all Florida not-for-profit corporations, so long as such corporations are described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code") and such other not-for-profit corporations described in Section 501(c)(3) Code of which the Corporation is the sole member.

III. The number of votes cast for the amendments to the Articles of Incorporation by the members were sufficient for approval.
