

Mid-Florida Property Management, Inc. terminated the management relationship with the Sunset View Homeowners Association, Inc. in Apopka effective February 15, 2002. At that time, the representative of the homeowners association indicated that they would make the necessary changes on the 2002 Uniform Business Report form (change principal place of business address, change mailing address and change the name and address of the registered agent). **HOWEVER**, when I recently checked the Division of Corporation records (copy enclosed), I noticed that when the homeowners association filed their 2002 UBR, they changed the principal place of business address and the mailing address but not the name and address of the registered agent as they had indicated to me.
